5. Metals Testing: Liability vs. Grinding Everything to a Halt

Due to the recent rollout of "Green Screen Certification" from our partners Center for Environmental Health, and CEH's unwillingness to continue okaying any reusable products that fall short of their new standard, PFR will be instituting the following changes regarding the testing of reusable food ware purchased or subsidized on behalf of schools:

- --If a reusable food ware category (e.g., stainless steel trays) has a product that has passed Green Screen Certification, then that product will be the only one subsidized by PFR for schools moving forward.
- --If a reusable food ware category (e.g., stainless steel cups) does not yet have a product that has passed Green Screen Certification, then PFR will subsidize any product that has passed either EN13130 or ASTM C738 acid bath migration testing on three samples at a certified lab of PFR's (or CEH's) choosing, with resulting metals concentrations detected at <0.01ppm Lead, <0.005ppm Cadmium, <0.25ppm Chromium, and <0.14ppm Nickel.
- --Once a product is Green Screen Certified in a category (e.g., stainless steel cups) that previously had no products in it, then products from that category that fall short of Green Screen Certified status will no longer be eligible for PFR subsidies at schools.
- --PFR will cover at least 50% of the cost of the EN13130 or ASTM C738 tests, and will attempt to get the other parties (schools, manufacturers, CEH, ReThink Disposable) to cover the remaining 50% of costs whenever possible.
- --Because reusable food ware containing plastic is unlikely to pass a similar acid bath migration test for toxins, this new policy effectively means that PFR will no longer subsidize any reusable items containing plastic at schools.
